SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

Rinse eyes thoroughly with lukewarm water for at least 15 minutes. Do not allow the person affected to rub or close their eyes. If the injured person uses contact lenses, these should be removed unless they are stuck to the eyes, in which case this could cause further damage. By ingestion/aspiration:
