4 SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

Contact with Skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Seek medical

advice if irritation occurs.

Contact with Eyes: Rinse eyes gently with lukewarm water for at least 15 minutes, keeping eyelids open.

Avoid strong water jet. Remove contact lenses if present and easy to do. Consult an

ophthalmologist if irritation persists.

Ingestion: If small amount is swallowed, rinse mouth with water. Do not induce vomiting. Seek

medical advice and show the label or packaging.

Inhalation: Move the affected person to fresh air. Keep warm and at rest. If symptoms persist or

worsen – consult a physician.

4.2 Most important symptoms and effects, both acute and delayed

4.3 Indication of any immediate medical attention and special treatment needed

5.3 Advice for firefighters

General protective measures typical in case of fire. Do not stay in the fire-exposed area without suitable chemical-resistant protective clothing and self-contained breathing apparatus. Prevent fire-fighting water from entering sewage systems, surface water and groundwater.

6 SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Avoid contact with eyes and skin. Do not inhale vapours or mist. Use appropriate protective equipment. Remove all sources of ignition. Keep unprotected persons away from the contaminated area. In case of a large spill – warn users and instruct bystanders to leave the contaminated area. Do not touch or walk through the spilled material.

6.2 Environmental precautions

Do not allow to enter drains, surface water or soil. In case of larger spills, notify appropriate emergency services. Prevent further leakage or release into the environment.
